

Community Suppers

Every Monday evening, 75 people from around Morgan Hill gather at St. Catherine of Alexandria Parish to enjoy a meal and fellowship as part of the parish's Community Suppers Program. Volunteers prepare and serve the meal for parishioners and non-parishioners alike.

Martha's Kitchen of San Jose, a noteworthy grant recipient of the Catholic Community Foundation, delivers hot entrées, dessert, and beverages each week at no cost to the parish. The result of these partnerships: camaraderie and stewardship.

With a grant from the Foundation, this year's menu is guaranteed to include fresh fruit, salad and vegetables. Until now, St. Catherine's



program has relied on donations from the community and volunteers to provide a fresh alternative to canned veggies.

Carol Lillig, Program Director, knows the addition of fresh produce will be met with great enthusiasm. She added, "Saint Catherine of Alexandria Parish is committed to serving the needs of our community.

Our Community Suppers Program caters to the most basic of our neighbors' needs, but goes beyond simply feeding the hungry. It lays a foundation of fellowship that, with the addition of our Catholic faith, sets a framework

for our parish community. We are thankful to our partners who allow us to offer this meaningful program."



A Shepherd's Enduring Gift

Bishop McGrath often visits Catholic schools in the Diocese. During these visits he encourages the children to ask him questions. Questions differ, but inevitably some children ask.

Krackeler Family Endowment

In middle school, the Sisters of the Sacred Heart encouraged Joe Krackeler to have the heart of Jesus. Throughout his life this foundation of faith and outreach was reinforced. Today, he continues to volunteer his time, talent and treasure to support the Catholic ministries that have shaped this life.

"We are blessed to be part of St. Nicholas Parish," said Joe, an active member of the parish and school for 45 years. "Our parish, Catholic high schools and universities, the religious orders and our involvement with The Order of Malta have been integral to the formation and growth of my family"

Joe turned to the Catholic Community Foundation for a way to acknowledge the ministries that formed him and his family. He chose to establish a Family Endowment.

A family endowment allows an individual or family to name beneficiaries in an endowment agreement with the Foundation. The endowment may be funded now, or at the death of the donor. The Foundation is named a beneficiary through a will or trust. When the donor dies, the gift to the Foundation is deposited in the Endowment. Every year FOREVER, the Foundation will grant from the family endowment to the named beneficiaries.

"There is great comfort in knowing the Catholic Community Foundation will be the steward of our gift," said Joe Krackeler. "Together, we are able to give lasting support to the ministries that have meant so much to our family."

Donating appreciated stock to my fund allows me to bypass capital gains taxes and conveniently advise grants to multiple charities that I support, instead of writing and mailing individual checks.

When I learned that I could partner with the Catholic Community Foundation, a local organization that supports my local interests, my decision to

move my Donor Advised Fund to their management was simple." Phil Anthony is an active parishioner at St. Elizabeth Parish in Milpitas. He uses his Donor Advised Fund at the Foundation to support local Catholic causes as well as national charitable organizations.

Many donors like Phil choose to transfer a commercial Donor Advised Fund to the Catholic Community Foundation, where they are provided the additional benefit of knowing that the fund will not only provide a necessary tax benefit, but will also support the Foundation's overarching mission.
