

Letter from the Board Chair and CEO



Dear Friends,

The culmination of the Foundation's work and the most important measure of our success is grant making. In 2023, we granted over \$10 million for the first time.

A major theme for us in 2023 was ENGAGEMENT.

We worked with many families to deepen and expand their philanthropy through thoughtful planning. Central to this engagement is the charitable equity that we hold for families in the form of Donor Advised Funds (DAFs). In 2023, we launched an innovative **Donor Advised Fund Match**, adding \$5.3 million to DAFs and creating the Catholic Impact Fund for targeted grantmaking to augment ministry and improve community.

As we look forward, we are pleased to be able to support the Pastoral Plan for the Diocese of San José which was announced in 2023. Bishop Cantú's plan will add beautiful context to our grant making and offer us the opportunity to inspire families in support of Diocesan ministry.

We also continued our deeply valuable relationships with trusted advisors. We partner with these professionals in support of families to craft creative and meaningful plans for current and legacy giving.

In 2023, we had five deeply committed directors term off of the board. We offer thanks for the ineffable value to Jim Cashman, Tom Crotty, Bertha Minnihan, C.S. Park, and Charmaine Warmenhoven. We look forward to a continued collaboration with these leaders.

Moreover, we express great gratitude to Jim Cashman, whose three years as board chair included guiding us through the pandemic.

Donor Stories

Doing Parishes Differently

The Legacy of Monsignor John Sandersfeld

Monsignor John Sandersfeld is remembered by those who knew him for his outgoing and welcoming personality and his passion for parish ministry. Along with the innumerable lives he touched through his kindness, generosity, and commitment to justice, Msgr. John's legacy also includes the newly formed **Monsignor John Sandersfeld Fund for Parish Mission Development**. Msgr. John started this fund with a gift from his estate plan with the vision that it would help fund the development of a collaborative model of ministry for both priests and lay leaders.

Msgr. John, a Los Gatos native and Bellarmine graduate, served at parishes in San José and San Francisco after his ordination in 1966. He spent two years studying parishes across the nation in the late 1970s as the Associate Director of the Parish Project of the National Council of Catholic Bishops' Committee on Parish Life. After returning to the Diocese of San José, he was named pastor of Most Holy Trinity parish in East San José where he served for eight years. Bishop Dumaine named him vicar for clergy. In 1993 he became the founding pastor of St. Francis Assisi Parish.

Throughout his life, he maintained that parishes need to be "done differently," with strong emphasis on relationships and engagement of the laity to propel the community forward. "Msgr. John's image of priesthood is that the pastor is in the middle of a parade," says long-time friend and colleague Fr. Joseph Benedict. "The pastor is not leading the parade, he's not pushing from the back. But rather he's in this great pilgrimage of discipleship – animating, guiding, and caring for the community." Msgr. John's goal was to empower people to minister so that community members could care for each other.

The new Monsignor John Sandersfeld Fund for Parish Mission Development will continue his



legacy through funding workshops and trainings on a more collaborative model of ministry for both priests and lay leaders at local parishes. This model emphasizes the universal call to holiness, the equality we each have in baptism, and the common call to service within the community.

Fr. Joseph spent six years working with Msgr. John at St. Francis of Assisi and described his work style as "creative chaos." He had an engineer's mind with a charismatic, warm personality and great concern for others. "Msgr. Sandersfeld's entrepreneurial spirit definitely formed and shaped me," said Fr. Joseph. "I'm a better priest because of John. I'm a better person because of John."

A DAF Partner that Shares our Values

Rene and Amy Ho believe in the importance of giving back to their community and setting an example for their children. When they learned about Donor Advised Funds (DAFs) at the Foundation, they were drawn to the idea of partnering with a Foundation that could help them figure out how to give from their DAF in a thoughtful way that reflected their family values.

Rene has been involved at their parish, the Catholic Community at Stanford, for many years, and he first learned about the Foundation through his involvement with the parish Finance Council. When they found out that a Catholic DAF partner existed, he and Amy were curious to learn more. They liked their existing DAF provider, however the idea of partnering with an organization that was aligned to their values resonated with the couple. "We were very interested in the opportunity to work with an organization that understands our Catholic values," said Rene. "We also wanted to have deeper conversations about how we give and how to get our children more involved in philanthropy. After talking to the Foundation, we knew that they would be a great partner as we explored these ideas."

Moving their DAF was simple. This can be achieved by simply making a grant from an existing DAF to the Foundation. They were doubly motivated to move their fund because of the Foundation's ongoing Donor Advised Fund Match opportunity (see more details on pages 5-6 of this report). "Opening the fund has been simple and pain-free. They make it easy, and the staff is very accessible," said Amy.

Now that the "easy" part is done, it's time to dive into the more complicated – and more interesting – questions about their family's philanthropic strategy and goals. In conversation with the Foundation, they will explore topics like their motivations for giving, their family values, how to integrate the whole family into the decision-making process, what they want their



legacy to be, and more. "We wanted to work with a partner who would walk with us through these questions and help keep us on track," said Rene. "Knowing we have a team of people we can rely on for support who will keep moving this process forward is hugely valuable for our family."



In October of 2023, the Foundation announced a match for contributions to new and existing Donor Advised Funds (DAFs). Sponsored by a generous donor, the match has two aims:

▶ to increase the impact of donors' giving via Donor Advised Funds

▶ to create a new, flexible grantmaking fund that the Foundation can use to respond to current needs in our community – the Catholic Impact Fund There was a lot of enthusiasm from current and new fund holders around the match right off the bat! By December 31, 2023, about half of the available matching money had already been used.

Catholic Impact Fund

This fund was created to allow the Foundation to respond to the changing needs of our community, guided by our Gospel call to love and serve our neighbors. Since the fund is not endowed, the Foundation has the flexibility to respond to needs as they arise and create a positive impact when and where it will be most effective.

What is a Donor Advised Fund?

A Donor Advised Fund (DAF) is a simple, centralized account for all your charitable donations. You receive an immediate tax deduction for your contributions to your DAF and then can take your time deciding which organizations you want to support.

The Gift of Giving

A number of donors were inspired to take advantage of the DAF Match not only for their own DAFs, but to create DAFs for their children. The idea of "giving a DAF for Christmas" caught on with families who wanted to engage with their adult children or grandchildren around topics of gratitude, generosity, and legacy.

Frank and Gayle Boitano were one such couple who decided to give their daughters and sons-in-law the "gift of giving." They began the conversation about philanthropy with their daughters and spouses during a family vacation over the summer, revisited the topic at Thanksgiving, and gifted them the DAFs at



Christmas. "We know that getting Lindsay and Lauren more engaged and excited about giving will take time," said Frank. "Gayle and I hope that our legacy of philanthropy will live on through our daughters and their families. We feel that it is more beneficial to get them involved today while we can encourage and mentor them in the 'gift of giving.'"

Creating a Philanthropic Plan

Andy and Trish O'Donnell have always deeply valued giving back to the community; however, as busy professionals raising a daughter, it was challenging to find sufficient time to dedicate to the causes close to their hearts. That is all changing now as they are entering into a new chapter in their lives: retirement. Their first retirement goals are to create a strategic plan for their philanthropy and get their daughter involved in aspects of their philanthropic plan.

While they were working full time, they capitalized on opportunities to increase their impact and grow their philanthropic "nest egg." They leveraged the matching programs from their workplaces as well as the Foundation's first



Donor Advised Fund Match in 2018 and this most recent match in 2023. They also took advantage of the tax benefits of transferring equity positions that had high taxable capital gains. In doing so, they made a conscious decision to grow their DAF over the years before retirement so that they would have a substantial base set up for their future philanthropy.

Now the fun begins. "I'm looking forward to giving back and having more time to volunteer on projects that I am passionate about, where I can add value, and help make a difference in our community," said Trish. With the guidance of the Foundation, the O'Donnells are creating a plan for how they would like to give their time and money. The Foundation is able to introduce the couple to organizations based on what inspires them and connect them with other families with similar interests.

"We appreciate the guidance and resources provided by the Foundation staff," said Andy. "They are working with us on the steps to creating a plan for our philanthropy, and now we get to build something that is more meaningful for us and creates a positive impact for others."



Grants

Mental Health Support for Catholic School Students

In 2021, a coalition of experts in pediatric health declared a national emergency in child and adolescent mental health. Rates of childhood mental health concerns and suicide have risen steadily since 2010, and by 2018 suicide was the second leading cause of death for youth ages 10-24.¹

In 2020, Foundation staff were having conversations about this topic with a number of donors who were concerned about this issue, especially in light of the strains of the pandemic on school-aged children. **The Pillar of Hope Fund was created to provide counseling and intervention services for low-income students attending Catholic schools in Santa Clara County.** The fund has been granting since 2021 and has already made a significant impact on children, families, and teachers in underserved communities.

The Pillar of Hope Fund utilizes the services of CASSY – Counseling & Support Services for



Youth – to provide highly qualified postgraduate therapists to the campuses of 6 Diocesan elementary schools 1-3 days a week. Parents and staff alike are relieved to have resources available on campus so they don't have to go to a second location.

Capstone Advisor Session 2023

Each year the Foundation hosts an event for advisors to network and hear from speakers on topics of philanthropy.

Expanding the Definition of Philanthropy

On June 15, 2023, advisors from around the Bay Area gathered in San José to hear from a panel of experts about how philanthropy is changing and expanding. The panel examined how advisors can support clients as they explore philanthropic options and open the conversation to new ideas for giving.

James Cashman, Partner at Berliner Cohen, observed how his approach to the topic of philanthropy shifted over the years from an add-on at the end of a conversation with clients to an overt and purposeful topic of discussion throughout the estate planning process. Tom Crotty, Family Office Practice Leader at Sensiba San Filippo LLP CPAs, talked about the importance of understanding the purpose of the client's wealth – what are their guiding principles, what legacy do they want to leave - in order to help them make better strategic decisions. In addition, Julia Matsudaira, Senior Vice President of the Impact Advisory at Jordan Park, spoke about macro trends and her experience with clients who are interested in creative solutions to timely problems and the growing emphasis on impact and results.

CAPSTONE ADVISOR SESSION

The buzz of networking and discussion among attendees during breakfast was energizing. "I look forward to this event every year," said Brandon Rebboah, Partner at Berliner Cohen. "It's a great group of professionals and the content is always thought-provoking. I wouldn't miss it."
